Official Birthday Party Giveaway Rules & Regulations

These are the official rules that govern the operation of the Birthday Party Giveaway taking place January 1 - 31, 2025. This Raffle is sponsored by Kids Quest, Inc. ("Sponsor") and is no way sponsored, endorsed or administered by, or associated with Facebook or Instagram. **Void where prohibited by law or where prior registration or approval is required, including, but not limited to, Arizona, Puerto Rico and other US territories or possessions.**

1. **Eligibility:** This Raffle is open to individuals who meet all the following criteria:
 - a. By entering a submission in the Birthday Party Giveaway, you affirm that you are at least 18 years of age, or an emancipated minor, or at least 13 years of age and possess legal parental or guardian consent to participate in this Raffle and that you are fully able and competent to enter into terms, conditions, obligations, affirmations, representations and warranties set forth in these official rules.
 - b. You are not an employee of Sponsor or any Sponsor parent, subsidiary or group company;
 - c. You are not involved in any part of the administration and execution of this Raffle.
 - d. You are not an immediate family (parent, sibling, spouse, child) or household member of:
 - i. An employee of Sponsor or a Sponsor parent, subsidiary or group company; or
 - ii. A person involved in any part of the administration and execution of this Raffle.

 - b. Guests who purchase a Daily Quest Bonus of \$25 or more at **Cyber Quest** will receive a raffle entry.
 - i. **All Star / MVP / Legend Cyber Quest Club Cardholders** receive an additional raffle entry for each Daily Quest Bonus purchase of \$25 or more.
 - c. The entry must fulfill one of the Raffle requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Kids Quest.
